Important Update on Anticipated WAC Price Reductions Effective as of December 2023 and January 2024

We want to bring your attention to an important update. Certain manufacturers have publicly announced plans to decrease WAC pricing on several brand prescription ("Rx") items. The anticipated effective dates of these price reductions could be as early as December 2023 and January 2024, but they may vary based on manufacturer direction. As of this time, the Rx items affected by the WAC price reductions are listed in the table below.

Frequently Asked Questions

1. When will the price reductions take effect?

Eli Lilly announced reductions to the list price of the NDCs identified on the table to be effective as of late Q4 2023. Novo Nordisk and Sanofi announced reductions to the list price of the NDCs identified on the table to be effective as of January 1, 2024.

2. How should pharmacies and other providers manage current inventory purchased before these anticipated price reductions?

We anticipate the release of manufacturer guidance on inventory levels heading into the price reductions in the near future. McKesson is committed to sharing the latest information as soon as it is available.

3. What is McKesson doing to facilitate a smooth transition?

McKesson is taking several steps to facilitate a smooth transition and help minimize customer impact and disruption including:

 McKesson plans to preload the new WAC prices for impacted items for the corresponding effective dates. McKesson is in constant communication with the manufacturers and is committed to providing updates to the list of impacted items and any manufacturer programs as more information becomes available.

- McKesson is committed to working with manufacturers to limit potential disruptions to our customers. McKesson will begin to limit returns for any impacted products.
- Allocation limits, if any, will be set at a percentage above actual historical purchases to facilitate
 equitable access and distribution of our available inventory. Historical purchase patterns should not
 be impacted by these short-term limits.
- 4. Will manufacturers have a program via wholesalers to mitigate impact on downstream customers related to this action?

Some manufacturers may provide programs to help customers mitigate the impact on inventory. Eligibility and program terms will be determined by the specific manufacturers.

5. Will I be able to return product of impacted items and receive credit for items purchased at the older, higher price?

No. On December 1, 2023, a returns block will be in place and remain in effect until January 1, 2024 on all product sales of impacted items to the customers. This means that all impacted items purchased before January 1, 2024 will be ineligible for a return. However, any impacted items purchased on or after January 1, 2024 at the new WAC price will be returnable after January 1, 2024.
