Any single contributions to Ernst Victory from an individual or federal non-multicandidate PAC shall be distributed to the Committees in the following order, up to the maximum allowed under the Federal Election Campaign Act: (Joni for Iowa 2020 Primary Election funds up to \$2,800, Joni for Iowa 2020 General Election funds up to \$2,800, and Jobs, Opportunity, and New Ideas PAC up to \$5,000). Any federal multicandidate PAC contribution shall be distributed to the Committees in the following order, up to the maximum allowed under the Federal Election Campaign Act: (Joni for Iowa 2020 Primary Election funds up to \$5,000, Joni for Iowa 2020 General Election funds up to \$5,000, and Jobs, Opportunity, and New Ideas PAC up to \$5,000). Contributions are not tax deductible for federal income tax purposes. Federal law requires us to use our best efforts to collect and report the full name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 per election cycle. Contributions from corporations or foreign nationals are prohibited.
