

### Outreach:

- \* NCPDP PDMP Stakeholder Action Group meeting in Phoenix, AZ. The goal of this meeting was to identify current issues and future solutions regarding PDMPs, in addition to exploring healthcare technologies and standards designed to better equip clinicians to care for their patients.
- \* The ED attended APhA Annual meeting in Seattle, WA. and met with meetings with PHIT members, volunteers and other prospective PHIT members.

#### Policy and Advocacy:

With the help of David Kosar (Collaborative's Policy Analyst) PHIT was active this month with the following:

\* On March 29, 2019 PHIT submitted a comment letter to Congressional Telehealth Caucus of United States Congress regarding the request for information on the revised Telehealth package. Pharmacists are users of health IT and telehealth. The Collaborative supports the use of health IT and telehealth, which are important to pharmacists for working with other health care providers to transmit patient information related to overall patient care, transitions of care, immunizations (historical and administered), immunization registry reporting, medication lists, medication allergies, allergy reactions, patient problem lists, smoking status, reporting to public health agencies, clinical decision support services/knowledge artifacts, drug formulary checking, a n d e l e c t r o n i c p r e s c r i b i n g . http://www.pharmacyhit.org/pdfs/collaborative-outreach/
