To support our valued customers during this transition, we are pleased to share details about a limited rebate program (LRP) for eligible purchases made between December 14, 2025, and December 27, 2025.

Program Details

- **Eligibility:** Eligibility for the LRP is determined based on trade classification.
- **Complete Claims:** Claims must contain complete information. Submissions, for which we, your wholesaler, are required to blind, block, or otherwise exclude store-level information are not eligible.
- **MFP Adjustment:** Units for which Boehringer Ingelheim effectuated a rebate pursuant to the Medicare Drug Price Negotiation Program using 2025 WAC through an adjustment (raised via a Good Faith Inquiry) are ineligible for the LRP.
- **Rebate:** The credit amount will be calculated as: (Quantity purchased between 12/14/25 and 12/27/25 – quantity rebated through MFP) x (Old Purchase price – New Purchase Price).
- **Credit Issuance:** We anticipate issuing credits to eligible customers in March of 2026; however, the timing may vary depending on the completion of each step, including verification of eligibility, calculation of purchases and processing.
