

February 2026 Humalog® (insulin lispro) U-200 and Lyumjev® (insulin lispro-aabc) Limited Duration Rebate Announcement

Effective February 1, 2026, the following products will undergo 70% reductions in Wholesale Acquisition Cost (WAC): Humalog U-200 KwikPen®, Lyumjev U-100 KwikPen, Lyumjev U-200 KwikPen, Lyumjev U-100 Vial, and Lyumjev U-100 Tempo Pens™. The decision to reduce the price of these presentations aims to further align pricing of these presentations with the rest of Lilly's meal-time insulin analogs and continue to expand upon Lilly's prior effort to close the gaps in the U.S. healthcare system that keep some people from accessing affordable insulin.

Lilly recognizes that changes in the list price of prescription medications may have financial implications for its business partners in the channel, particularly for pharmacies who dispense these medications to patients.

In an effort to avoid supply chain and patient access disruptions that could result from the channel's response to the 70% WAC price reductions, **Lilly will be offering a Limited Duration Rebate of 70% off the current WAC prices on Humalog U-200 KwikPen, Lyumjev U-100 KwikPen, Lyumjev U-200 KwikPen, Lyumjev U-100 vials, and Lyumjev U-100 Tempo Pens purchased at WAC from Lilly Authorized Distributors of Record during the period of January 17th – January 31st, 2026.** Lilly will not be offering a "shelf stock adjustment" after the price decrease on February 1st, 2026.

- To receive the rebate, customers will purchase affected product from a Lilly Authorized Distributor of Record (ADR) as they normally do during the limited duration period of January 17th – January 31st, 2026.
- Lilly will partner with Distributors to credit pharmacies the rebate amount on eligible purchases after a validation process.
- **Eligible Product that is purchased at any contracted or up-front discount (except for discounts which may be available from wholesaler subject to agreement between customer/wholesaler) will not be eligible for this rebate.**

The expectation is that the validation process and wholesaler credit process for rebates will be completed in a timely manner.
